**ORDINANCE #2021-002**

**WHEREAS**, the Zoning Ordinance for the City of Samson, Alabama, was previously adopted by reference pursuant to Section 11-52-77(3), Code of Alabama, 1975, as amended on the 4<sup>th</sup> day of January, 2000;

**NOW THEREFORE BE IT ORDAINED**, by the governing body of the City of Samson, County of Geneva, State of Alabama, the Zoning Ordinance for the City of Samson, Alabama, is now amended as follows:

**SECTION 1. THE ZONING ORDINANCE FOR THE CITY OF SAMSON, ALABAMA**, is printed in booklet and manual form. The Zoning Ordinance was prepared by the Southeast Alabama Regional Planning and Development Commission, Dothan, Alabama. The Zoning Ordinance is on file in the Office of the City Clerk, Samson, Alabama. The purpose of the Zoning Ordinance is to promote the health, safety, convenience, order, prosperity and the general welfare of the residents to lessen congestion in the streets; to secure safety from fire, panic and other dangers; to promote health and the general welfare; to provide adequate light and air; to prevent the overcrowding of land, and to avoid undue concentration of population; to facilitate the adequate provision of transportation, water, sewerage, schools, parks; to facilitate initiation of the comprehensive plan and other public requirements.

**SECTION 2. THE ZONING ORDINANCE FOR THE CITY OF SAMSON, ALABAMA**, prepared by Southeast Alabama Regional Planning and Development Commission, Dothan, Alabama, Paragraph 10.31, Application Fee, is hereby amended to read as follows:

An application fee for matters appearing before the Commission and the Board of Adjustment will be accompanied by cash or check, payable to the City, in the amount of \$100.00.

**SECTION 3.** This amendment to the Zoning Ordinance for the City of Samson, Alabama, prepared by Southeast Alabama Regional Planning and Development Commission, Dothan, Alabama, shall take effect upon adoption and publication of this Ordinance enacting said Zoning Ordinance into law by reference.

**SECTION 4. ADOPTION:** The foregoing Ordinance was unanimously adopted this 4<sup>th</sup> day of May, 2021.
