# AMENDMENT TO CITY OF SAMSON DEFERRED COMPENSATION PLAN

WHEREAS, the City of Samson (hereinafter, "the Employer") desires in conformity with the resolution of its governing body to amend the City of Samson Deferred Compensation Plan (hereinafter, "the Plan"), to the extent and in the manner hereinafter set out; and,

NOW, THEREFORE, the Employer, duly authorized by the aforesaid resolution does hereby amend the Plan, effective February 1, 2016, in the following particulars:

The Employer has terminated the Plan. As a result, Deferred Compensation shall not be permitted after such date, Deferred Compensation made prior to that date will be distributed in accordance with the provisions of Article VII of the Specimen 457(b) Deferred Compensation Plan document.

Notwithstanding anything in the Plan to the contrary, the following shall apply with respect to any distribution made from the Plan after the effective date of this amendment or, if later, the date this amendment is adopted:

- (a) The Plan Administrator shall distribute to each Participant former Participant, or Participant's Beneficiary any amount to which he is entitled under the Plan in one lump sum payment by check.
- (b) No consent shall be required for any such distribution under the Plan.
- (c) Participants, former Participants, and Participant's Beneficiaries shall be prohibited from electing benefits in the form of an annuity.
- (d) If the total amount payable to a Participant, former Participant, or the Participant's Beneficiaries does not exceed \$1,000.00 and the Participant does not elect a direct rollover of the amount to eligible retirement plan, then the total amount shall be distributed in one lump sum payment by check.
- (e) If a distribution greater than \$1,000.00 is payable to a Participant or former Participant and if the Participant or former Participant does not elect to have such distribution paid directly to the "eligible retirement plan" specified by the Participant or former Participant in a direct rollover (in accordance with the direct rollover provisions of the Plan) or to receive the distribution directly, then the Administrator shall pay the distribution in a direct rollover to an individual retirement plan designated by the Administrator.
